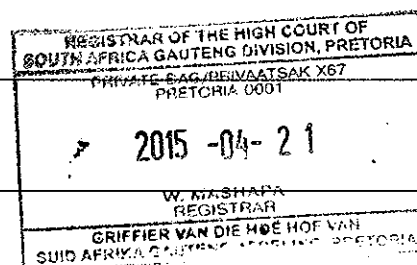

DRAFT ORDER

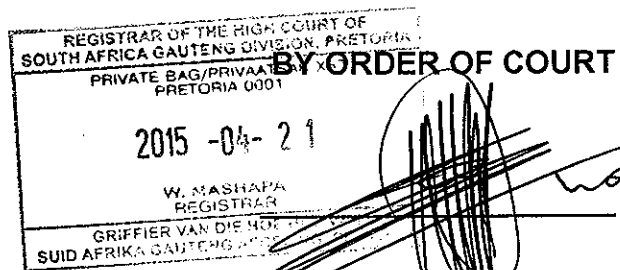


Having heard counsel and having read the documents filed on record, it is ordered that:
