CAXTON AND CTP PUBLISHERS AND PRINTERS LIMITED/ THE TRUSTEES FOR THE TIME BEING OF THE MEDIA MONITORING PROJECT BENEFIT TRUST/ S.O.S SUPPORT PUBLIC BROADCASTING COALITION / MULTICHOICE PROPRIETARY LIMITED / SOUTH AFRICAN BROADCASTING CORPORATION SOC LIMITED / THE COMPETITION COMMISSION

- 1 We act for South African Broadcasting Corporation SOC Limited ("**SABC**") in the above matter.
- 2 Our client is the process of preparing answering papers in this matter and although it will not be possible to file its answering papers within the required timelines contained in the Applicants' papers, it will file the answering affidavit as soon as reasonably possible. To the extent necessary, and unless the applicants grant our client a reasonable extension to deliver its answering papers, a condonation application will be brought in due course.
- 3 Since the applicants were aware of the agreement that forms the subject matter of this application for a substantial period of time but nevertheless only brought their application recently, they will suffer no prejudice by agreeing to afford the SABC a reasonable amount of time to deliver its answering papers. In any event, whilst we and the SABC will deal with this matter as expeditiously as possible, we record that the matter is not urgent.
- 4 In order to finalise its answering affidavit, SABC requires information regarding the authority of William Robert Bird and Sekoelane Jacob Phamodi to represent the Second and Third Applicants, respectively, and the *locus standi* of these Applicants.


